Guidelines for Use

1. The defoamer has excellent anti-foam and anti-foam performance. It can be added after the foam is generated or added into the product as a anti-foam component. According to different use systems, the addition amount of the defoamer can be 10~1000ppm, and the best addition amount is determined by the customer according to the specific situation.
2. Defoamer products can be used directly or diluted. If it can be fully stirred and dispersed in the foaming system, it can be directly added without dilution.
3. Do not add acid, alkali, salt and other substances to this product. Seal the container when not in use. If there are layers for a long time, stir evenly, generally does not affect the use of the effect.

Storage and Handling

Storage Temperature: Products should be stored in 0°C-30°C temperature environment, without direct sunshine, without getting wet in the rain and leaking water, without mixing impurities, without evaporation of water.

Shelf Life: It has a minimum shelf life of 6 months. Depending on storage conditions, the shelf life may be greater than stated. Please contact your us regarding suitability for use and dosage recommendations if the shelf life has been exceeded.
